




STOCK OUTBOARD CHAIRPERSON CANDIDATE - 2024

Throughout my own racing career, there have been two continuous issues facing Stock Outboard Racing. The first being equipment, its availability and viability. The second being membership and growth. My vision for Stock Outboard Racing is to develop plans that would help stabilize both of these issues while encouraging growth.

Most of the current equipment is no longer in production leaving us at a crossroad in our category. My vision includes looking into the actual availability of equipment in each class and planning accordingly. For example: are parts being reproduced, how many parts are there, are these parts available to everyone? Next, I would encourage the growth of the 4-Stoke classes. The steps of the previous commission allowed for new production equipment to be available to racers. The Stock Category should be fostering these efforts and helping build towards the future. With new motors, there is potential for class restructuring but not at the loss of membership.

Stock Outboard membership has been in decline for some time. Be it cost, equipment, or personal reasons, we need to find out why they are leaving and help retain membership while we grow. Driving schools already exist but I believe a lot of these driving school participants find it difficult to get equipment. Which leads back to my first point on equipment availability and viability.
